# Sustainable economic development - empowering women in water research Bridging the Gender Gap in STEM Researchg

Prof. Dr. Jane Catherine Ngila is a Kenyan **DAAD alumna of the Surplace/Third Country program** (1987–1989), **Visiting Professor** in Environmental Chemistry at the University of Johannesburg, one of the largest universities in South Africa and former Executive Director of the <u>African Academy of Sciences</u>. Since 2023, she has been the Executive Director of the <u>African Foundation for Women & Youth in Education, Sciences, Technology and Innovation</u> for the advancement of women and young people. She was recently appointed to the <u>United Nations 10-Member Group for technology facilitation mechanism</u> that supports the forum on STI for the SDGs.



#### **Contribution to water research**

Prof. Dr. Ngila has dedicated her life to research aimed at improving water quality and resource management on the African continent. In 2021, she was honored for the development of nanotechnology-based analytical methods for monitoring water quality to determine water pollutants, she was awarded the UNESCO L'Oréal Prize for Women in Science for her work in nanotechnology for water treatment.



#### Contribution to the advancement of women

In addition to water research, Prof. Dr. Ngila is dedicated to the **promotion** of **women** in **STEM subjects**. Her commitment is in line with the general efforts to empower women in STEM fields as well as youth in education and STI. The promotion of more women in water research aims to utilize different perspectives for innovative solutions to water problems. Recognizing the disproportionate impact of water scarcity on women, it advocates for their leadership. She was recently appointed to Membership of UNESCO Global Multistakeholder Advisory Committee for Women and Girls in Science.

#### Research for innovation in public health

Roshan Keshari is a fellow in the **DAAD Surplace/Third Country Program** (2020–2024) from **Nepal and is currently pursuing a PhD** in Biosciences and Bioengineering **at the Indian Institute of Technology Bombay** – one of the top 5 universities in India and part of the BMZ-funded Exceed network <u>Sustainable Energies</u>, <u>Entrepreneurship and Development</u>.



#### **Development of sustainable antiviral masks**

Roshan Keshari's research focuses on nanoscience. For example, he is committed to tackling urgent global health problems through interdisciplinary research and practical solutions. Keshari decided during the COVID pandemic not to return to his home country of Nepal, but to stay in India to work together with his caregivers to develop a low-cost, biodegradable mask with an antiviral protective film that is also effective against SARS-CoV-2. The antiviral mask made of sustainable material, which can be washed up to 20 times is now patented, ISO-certified and commercially available.

# Breaking the Glass Ceiling: Strategies for Women in Higher Education Leadership

The Ghanaian Prof. Dr. Nana Aba Appiah Amfo is an alumna of the **DIES programme** (2015) of **DAAD** and HRK. She is the **first female vice-chancellor (rector)** of the University of Ghana, the oldest and leading university in Ghana. She is a linguist and is committed to **gender equality** and **inclusive leadership** in academia. She also uses her network and qualifications from the International **Women's Forum Leadership Fellows Programme**.





#### Communication and inclusion are key

In the area of university management, women are in the minority in Ghana – similar to Germany and worldwide. What advice does she have for other women in leadership positions? "By no means use an autocratic leadership style, it doesn't work in the collegial environment of a university". Instead of dominance, Appiah Amfo recommends: "It's best to involve as many colleagues as possible in processes and decisions, treat them with respect and also consult the committees – even if it's difficult." Communication combined with a clear idea of where the journey is going is key, she says.

Prof Dr Palamagamba Kabudi, alumnus of the DAAD-In-Country/In-Region Programme (1984–1985), has been a Member of Parliament on the Local Government Affairs Committee since 2017, responsible for infrastructure projects in the municipalities, among other things. Between 2017 and 2022, he was Tanzania's Minister of Justice and Minister of Foreign Affairs. Prior to this, he worked as Dean of the Faculty of Law at the University of Dar es Salaam from 2009–2012 and served as Secretary to Council and Dean of Ceremonies. Between 2011 and 2014 he was a Member of the Constitutional Review Commission. He also served as a consultant for the Government for drafting of the following pieces of Legislation: Environmental Management Act, Wildlife Conservation Act, Forest Act, Beekeeping Act, Water Resources Management Act and Urban Water Supply and Sanitation Act.
