## Priorities and Project Activities

- The establishment and operation of the **International Digital Learning Support** at RUB for the coordination of digital teaching.
- Individual **advice and support for lecturers and students** on UNIC teaching, in particular on the implementation of **virtual exchange/mobility**, but also on **physical/blended mobility** and the promotion of cooperation in teaching in UNIC in general.
- An **incentive programme** for lecturers in the form of personnel support from research assistants/staff.
- **Increasing** participation in the development of courses with virtual exchange/blended mobility within UNIC.
- **Adapting the IT environments** for mobility to UNIC requirements, thereby enabling the **digital transfer of student data** and creating the technical prerequisites for data exchange within UNIC.
- The development of RUB's internal campus management systems towards **integration within the EUN** and the introduction of the joint **(UNIC) European Student Card**.
